Match 3: Air Rifle 60 shots (10 shot Strips or Electronic Targets to be used.)

Trophies: 1st, 2nd, 3rd in each grade, 1st ungraded Junior (under 21). IPC: 1st, 2nd, 3rd Categories SH1, SH2

Match 4: Air Rifle Supported 60 shots (10 shot strips or Electronic Targets to be used.)

Trophies: 1st, 2nd, 3rd in each grade, 1st ungraded Junior (under 21).

Match 5: 20m Benchrest 3 x 20 shots (Only using Official TRV 2017 20 scoring aiming mark BR Targets.)

Trophies: 1st, 2nd and 3rd in each grade, 1st ungraded in Junior and Sub-Junior.

Match 6: 50m Benchrest 3 x 25 shots (Official 2015 TRV 25 scoring aiming mark BR Targets to be used.)

Trophies: 1st, 2nd and 3rd in each grade, 1st ungraded in Junior and Sub-Junior.
