

# TARGET RIFLE VICTORIA INC

## Equipment Borrowing Agreement

The borrower acknowledges and agrees that the equipment listed hereunder:

1. Belongs to and remains the property of Target Rifle Victoria Inc.
2. Equipment is covered by TRV insurance when being transported and at the club or other temporary location, provided when not in use it is locked in a vehicle or premises.
3. Equipment was despatched from the TRV storage location in good working order or condition.
4. That the borrowing Club, and its members, must accept all responsibility for the safe and appropriate operation of the equipment.
5. That the equipment is only used in the manner it was intended, without modification.
6. That the equipment is returned in the same condition it was lent and within the agreed time and date shown hereunder.
7. In the event the equipment is lost, stolen, or damaged, a written report must be supplied to TRV with an appropriate copy of a police report, if that has been made.
8. Where TRV trailers or horse float are borrowed with the equipment, the vehicles towing the trailer or horse float must be legally appropriate for the task.
9. Should an accident occur during transportation, or theft or damage occur at the Club, the Club or member is liable for the excess payable in the TRV insurance policy.
10. In the event the equipment borrowed is returned in a damaged state to TRV, the Club borrowing the equipment hereby agrees to reimburse TRV for the full cost of repairs, to make good the equipment in the condition that it was lent.
11. If the equipment is being used at an event sponsored by a TRV Club, but is not a TRV event, there will be a hire charge for the Meytons.
12. The Meytons must be returned to the storage location, no later than seven days following the conclusion of the event.
13. If the borrowing Club or individual is unable to, or fails to, return all equipment to TRV, TRV will arrange for the collection of the equipment. A failure of the borrowing Club, or individual, is acceptance of the reimbursement for time, vehicle wear and tear. The general pre-estimate of these costs is \$2 per kilometre for each vehicle required to collect and return the equipment. The payment of this amount is due 30 days from the original agreed date for the equipment.
14. A hire fee of \$200 will be charged to cover the cost of minor incidental damage or wear and tear (not including broken, damaged or missing cable clips) to the equipment hired.
15. Should all equipment be returned in good order and undamaged, TRV will return \$100 to the borrowing Club or member within 30 days of the return of the equipment.

on record by TRV and a copy returned to the borrowing Club.
